Important Updates to MUSC's Policy on Recruitment of Research Participants

As of January 2021, MUSC has a new policy regarding recruitment of research participants. MUSC used to be an "opt-in" institution, where patients would agree to be contacted for research opportunities through MyChart. This new policy addresses MUSC moving to an "opt-out" institution when it comes to contacting patients about research opportunities. This means that some study teams, after getting IRB approval and completing the appropriate cold-contact data request process, will be allowed to reach out to any patient who meets eligibility criteria for their projects who has not opted out of being contacted for research opportunities.

PI Responsibility When Leaving MUSC

It is the Pl's responsibility, when leaving MUSC, to either close out their study with the IRB or transfer the study by amendment to another PI prior to leaving. If you are planning to leave the institution and still have open studies with the IRB, contact an IRB Staff Member to develop a plan for closure or a PI change amendment. It is important to note that a study should not be left to expire. Please refer to the Off-Boarding Checklist below when leaving the institution.

PI Responsibilities When Relying on an External IRB

Keep in mind that if MUSC relies on another IRB, you as the MUSC PI still retain considerable responsibility. In summary, you must:

- Ensure all members of your study team are appropriately qualified.
- Comply with the determinations and requirements of the Reviewing IRB.
- Maintain appropriate copies of all approvals, and other correspondence documenting the review and approval of the research as required by the regulations.
- Submit a modification to the MUSC IRB if/when:
 - New personnel are added to the study team.
 - The study is modified in such a way that additional institutional approvals are required (e.g., radiation safety, conflict of interest).
 - Changes are made which affect institutional policy/state law requirements.
- Report promptly to the Reviewing IRB any proposed changes in the research.
- Report to the Reviewing IRB any unanticipated problems involving risks to participants or non-compliance.
- Report to the Reviewing IRB as well as the MUSC IRB any complaints from a subject or other person regarding the research.

Editing the Personnel List and then Lose Access to the Study?

If you are revising/editing the personnel list on a study and then lose access to continue editing the study after clicking the continue button, you may have removed or replaced yourself on the study. Because of this, the system no longer recognizes you as someone with rights to the study (you may also have been logged out of the system with no access to that protocol). To move forward, you may request someone who's listed as personnel with edit rights to add you back onto the study. Otherwise, you will need to contact your institutional eIRB administrator for assistance.
